**Item 5.07 Submission of Matters to a Vote of Security Holders.**

On June 23, 2022, Verint Systems Inc. (the "Company") held its 2022 Annual Meeting of Stockholders (the "Annual Meeting"). The following is a brief description of each matter voted upon at the Annual Meeting, as well as the number of votes cast for or against each matter and the number of abstentions and broker non-votes with respect to each matter, as applicable. A more complete description of each matter is set forth in the Company's definitive proxy statement filed with the Securities and Exchange Commission on May 6, 2022 (the "Proxy Statement").

1. *Election of Directors.* The Company's stockholders elected the following persons as directors to serve for the following year or until their successors are duly elected and qualified:

2. *Ratification of Deloitte & Touche LLP as the Company's Independent Registered Public Accounting Firm.* The Company's stockholders ratified the selection of Deloitte & Touche LLP as the Company's independent registered public accountants for the year ending January 31, 2023. The results of the voting were 65,157,877 votes for, 2,480,349 votes against, and 14,859 abstentions.
  3. *Approval of Named Executive Officer Compensation.* The Company's stockholders approved, on a non-binding, advisory basis, the compensation of the Company's named executive officers as disclosed in the Proxy Statement. The results of the voting were 61,137,022 votes for, 4,270,758 votes against, 38,731 abstentions, and 2,206,574 broker non-votes.
  4. *Approval of Amendment to Amended and Restated Certificate of Incorporation.* The Company's stockholders approved an amendment to its Amended and Restated Certificate of Incorporation to increase the total number of shares of authorized Common Stock from 120 million shares to 240 million shares. The results of the voting were 65,131,182 votes for, 2,509,230 votes against, and 12,673 abstentions.
